

Increase in membership fee from April 2018

The society's fee was last increased in April 1998. With regret it is necessary to raise our fees to cover the much greater running costs of holding meetings, printing and postage.

The new charges are

- £10 pa for a single person and £15 for a household provided payment is by standing order
- If payment is not by standing order the charge will be £12 for a single person and £17 for a household
- The new charge will take effect from April 1st, 2018. The fee is unchanged for 2017-2018.

All members are requested to update their new standing order instructions in good time for the year 2018-2019.

Members are reminded that they may cancel their standing order by instructing their bank or building society.
